ANNOUNCEMENT: Darwen Motorcycle Club will organise a Closed to Club Trial for solo motorcycles, held under the National Sporting Code, Standing Regulations of the ACU, the North Western Centre Rules current at the time, the following Supplementary Regulations and any Final Instructions issued for the meeting. The competition will also be a round of the North Western Centre championship.

ELIGIBILITY: This trial will be open to members of clubs affiliated to ACU North Western Centre only. All riders and passengers must hold a current ACU/SACU Trials Registration Card or ACU/SACU Competition Licence. Any rider or passenger from another FMN must produce a licence issued by their FMN, together with start permission and proof of personal accident insurance.

MACHINES: Motorcycles as per NSC Appendix D Category 1, Group A1 Solos and TSR 8.

CLASSES: Adult, Youth

START / VENUE: 11am at Ramsgreave Hall Farm, Ramsgreave, Blackburn, BB1 9DQ

From the M6

Leave the M6 and head east on the A59, then the A677. Follow the A677 through Mellor Brook then take the A6119 on the left. At the second crossroads, turn left on Barker Lane, then right at the Spread Eagle. The entrance - marked Young Achievers - is a little further on the left.

From the east

Follow the A666 through Wilshire then turn west on Ramsgreave Road. This shortly becomes Higher Ramsgreave Road. Look out for a sign 'Young Achievers' to the right.

(NOTE: In line with National Sporting Code - Article 7.12 (*1); riders will be required to produce their current Competition Licence or Trials Registration when signing on at the start).

ENTRY DECLARATION: I, the undersigned, apply to enter the event described above and in consideration thereof:-

- 1) I hereby declare that I have had the opportunity to read, and that I understand the National Sporting Code of the ACU, the ACU Standing Regulations, such Supplementary Regulations as have and may be issued for the event and agree to be bound by them.
- 2) I further declare that I am physically and mentally fit to take part in the event and am competent to do so.
- 3) I confirm that I understand the nature and type of events and the risk inherent with the sport and agree to accept the same notwithstanding those risks may involve negligence on the part of the organisers or officials.
- 4) I further agree that I shall not seek to claim against the ACU, the organiser, nor their officials, the landowners, the promoter or other bodies or individuals connected with the event, in respect of any damage to property howsoever caused, and whether by the negligence or breach of statutory duty of the said bodies and persons.
- 5) I further agree that the machine that I enter and compete on, shall be suitable and proper for its purpose, shall be insured as required by the Road Traffic Act or equivalent legislation as necessary and that it will comply with the regulations in respect thereof. And is described below.
- 6) I understand and agree that I am required to register my arrival by signing-on at the event control or other designated area, prior to commencement of said competition.
- 7) I enclose the entry fee of £15.00 adults/£10 youths

Acknowledgement of the risks of motorsport: I understand that by taking part in this event I am exposed to a risk of death, becoming permanently disabled or suffering some other serious injury and I acknowledge that even in the event that negligence on the part of the ACU, the promoter, the organizing club, the venue owner, or any individual carrying out duties on their behalf were to be a contributory cause of any serious injury I may suffer, the dominant cause of any serious injury will always be my voluntary decision to take part in a high risk activity.
