ANNOUNCEMENT: Darwen Motorcycle Club will organise a Closed to Club Trial for solo motorcycles, held under the National Sporting Code, Standing Regulations of the ACU, the North Western Centre Rules current at the time, the following Supplementary Regulations and any Final Instructions issued for the meeting.

ELIGIBILITY: This trial will be open to members of Darwen Trials Club only. All riders and passengers must hold a current ACU/SACU Trials Registration Card or ACU/SACU Competition Licence. Any rider or passenger from another FMN must produce a licence issued by their FMN, together with start permission and proof of personal accident insurance.

MACHINES: Motorcycles as per NSC Appendix D Category 1, Group A1 Solos and TSR 8.

CLASSES: Adult, Youth

START / VENUE: 2pm at Back Lane, Southfield, Burnley BB10 3RD.

DIRECTIONS: Leave the A56 via Knotts Lane, following this lane which eventually becomes Back Lane for approximately 3 miles. Parking will be in a field off Back Lane. **In the event of poor weather, roadside parking may be necessary. Bikes must be pushed until they are within competition area. Failure to comply with this requirement will result in exclusion.**
